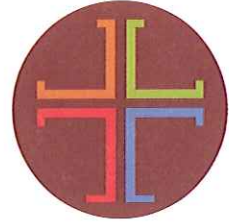

TO: Canonically Resident Non-Parochial and Retired Clergy in the Diocese of Missouri

RE: Determining Voting Eligibility at the 171st Annual Meeting of the Diocese

November 19-20, the dates of the 171st Annual Meeting of the Diocese of Missouri, are fast approaching. In preparation for that meeting, I send you the enclosed form with respect to voting at Diocesan Convention. This request relates to your voting eligibility at Diocesan Convention and should not be confused with the annual report that you are asked to submit to the Bishop.

The Constitution of the Diocese of Missouri states, in part:

1. *Every Cleric who is canonically resident and in regular standing shall have seat and voice in Convention.* (Title III, Article III.3, Sec. 3) (Note that this does not include vote.)
2. *The following clerics who are canonically resident and in regular standing shall have seat, voice AND VOTE in Convention: ...every Cleric who has served on a Diocesan committee during the preceding year or who has performed sacramental ministry in a Congregation of this Diocese on at least fifteen Sundays during the preceding year; every full time staff member of the Diocesan Office or of a Diocesan Institution or Agency;...(Title III, Article III.3, Sec. 4)*

In order to complete the compilation of the list of clergy who are canonically resident in the Diocese of Missouri and entitled to seat, voice, and VOTE in accordance with the Constitution of the Diocese, please complete the enclosed form and return it to the Diocesan Office by Friday, October 29, 2010. You will **not be eligible to VOTE** unless the completed form is returned to the Diocese of Missouri, 1210 Locust St., St. Louis, MO 63103 by that date, or by fax, (314) 231-3373.
